Pursuant to the inspection report (Ref.2), compliance report, undertaking submitted Ref. (6& 7) and AICTE approval (Ref.3), approval of the University is hereby conveyed for extension of Provisional affiliation for the following 5 UG courses with restored intake noted against each in **Sri Venkateshwaraa College of Engineering and Technology**, for the academic year 2017-18 subject to fulfilling the following conditions and subject to ratification by the Academic Council / Executive Council of the University:

The college should fulfill all the affiliation conditions as stipulated in our letter dated 18.05.2017 (Ref.4) as well as the requirements prescribed by A.I.C.T.E./ U.G.C. from time to time and as undertaken to comply with, in the undertaking submitted and the Compliance Report (Ref.6&7).

The observations of the inspection committee that have been agreed to be implemented should be complied without any compromise especially the condition regarding appointment of required faculty and the final compliance shall be informed within a month.

All faculty positions (14 vacancies) excluding present recruitment should be filled up without vacant position as per UGC/AICTE norms and the appointments should be made on permanent and full time basis in the presence of University nominee.

The list of faculty along with selection committee minutes should be submitted for approval of the University.

The College should ensure payment of salary to the teaching & Non-teaching staff as per UGC norms.

All changes in the teaching staff and other changes that may affect the fulfillment of the conditions for affiliation should be reported to the University within a fortnight.

Request for University nominee for appointment of faculty shall be sent to the University atleast one month in advance.

The Governing Body meeting should be conducted at regular intervals as per norms with University nominee in the Governing Body and minutes submitted to the University.

The College shall strictly follow the UGC Guidelines/Regulations 2009 on curbing the menace of ragging in Higher Educational Institutions (Under Section 26 (I) (g) of the University Grants Commission Act 1956).

The College shall constitute a Sexual Harassment Prevention Committee as per UGC notification dated 02.05.2016.

The Management of the institution shall discharge the statutory duties relating to pension, gratuity, provident fund etc. for its employees.

**Insurance, fire service NOC, Groundwater user license and PPA permit should be renewed periodically.**

Surprise checks will be conducted to ensure that all compliances reported have been actually taken care.

Admission of students should be made strictly in accordance with GOI/GOP/University norms. The College should collect fees as per the fee structure prescribed by GOP.


Excess admission made over and above the approved intake in respect of any course will not be considered by the University for approval under any circumstances.


In case of violation of any of the conditions of the University, the affiliation would be withdrawn and the college alone would be responsible for all consequences in this regard. In such an event, the affiliation fund would stand forfeited to the University.

This provisional affiliation shall be valid only for a period of one academic year i.e. 2017-18. Application for provisional affiliation for new course(s) / seat increase, if any, for the academic year 2018-19 should reach the Registrar, Pondicherry University on or before **1<sup>st</sup> October, 2017** and the request for renewal of affiliation for the academic year 2018-19 should reach before **7<sup>th</sup> January 2018**.

Admission for the next academic year 2018-19 should not be made/done without the approval of the AICTE and valid affiliation from the University.
