ANTI RAGGING POLICY

The Anti-Ragging Committee of Sri Venkateshwaraa College of Engineering and Technology is established in accordance with the All India Council for Technical Education (AICTE) regulations to prevent and combat the menace of ragging within the College premises. The Anti-Ragging Committee is committed to ensuring that our College remains a safe and nurturing environment for all Students. We will take proactive measures to prevent ragging and respond swiftly and effectively to any incidents that may occur. This policy encourages discouraging and preventing any negative acts on parts of senior Students, which goes against the basic purpose of socio-academic integration.

The Anti-Ragging Committee of SVCET aims to foster a Culture of respect and dignity within the College community, ensuring that all members feel safe and supported in their Educational and Professional pursuits.

The 'Anti-Ragging Policy' adopted by the Institute therefore is aimed at

- Keeping in place an integrated system to handle and prevent any initiative that has the potential to disrupt socio-academic integration of the new admissions.
- Any act that affects the mental health and self-confidence of a Student which may cause annoyance, hardship, physical or psychological harm will be considered a punishable offence.
- The membership of all Student clubs and Committees will be coordinated on the lines of this policy and conduct timed surveys to ensure authenticity of the committee. All concerned are to keep a constant vigilant watch at such locations, including monitoring of the atmosphere and the environment by posting security personnel.
- All Students of the Institute are required to sign an anti-ragging declaration forms (Annexure I and II) at the time of admission to the Institute.
- Any member within the campus who witnesses or experiences an occurrence of ragging shall report it immediately to the Secretary Member of the Anti-Ragging Committee or any of its members.
- If the complaint is found to be substantiated, the Committee shall recommend appropriate disciplinary action, which may include suspension or expulsion, to the College Management.
- Investigation and appropriate action against any individual or group found involved in ragging and liaising with law enforcement authorities will for criminal proceeding against perpetrators as required.
- Inquiries shall be conducted in a confidential and unbiased manner, respecting the privacy and dignity of the complainant and the respondent.

- Based on the report of enquiry submitted by the Secretary Member of **ARC**, any of the punishment/(s) listed below or any other kind of punishment, which he/she may consider to be appropriate, will be given.

- (a) Withholding scholarships or other benefits
- (b) Debarring from representation of events.
- (c) Expulsion from Institute.
- (d) Debarring from examinations.
- (e) Suspension from the institute or class for a limited period.
- (f) Fine
- (g) Prosecuting for criminal offence

Address by the Institute

All competent authorities during their meetings to/with Parents/Guardians, Admission Aspirants, Fresher's at the time of inaugurals, new batch induction on registration, batch inaugurals and other such occasions, must assure the Students and Parents about full protection and support against any attempts of ragging by seniors while briefly introducing the '*Anti Ragging Policy*' of the Institute New batch inaugurals. The Coordinator and Faculty members, during new batch inaugurals may provide to the Students, the guidelines on expected behavioral norms wherein a mention of the Anti Ragging Policy may be made.

Appeal

Appeal with concerns to any disciplinary action taken against the Student involved at any level under this policy, shall lie with the Principal, which should be filed within a period of two weeks from such an action or award of punishment.

Interference clause

Principal of the Institute will with hold all authority for any interference or amendment to the Policy depending upon need from time to time.
