MEMORANDUM OF UNDERSTANDING

BY AND BETWEEN

**SRI VENKATESHWARAA COLLEGE OF ENGINEERING AND TECHNOLOGY.,
No. 13A, Pondy - Villupuram Main Road, Ariyur, Puducherry 605102 and
Campus Connection, Chennai**

1. Scope

This Memorandum of Understanding ("MoU") is entered into by and between SRI VENKATESHWARA COLLEGE OF ENGINEERING AND TECHNOLOGY., No. 13A, Pondy - Villupuram Main Road, Ariyur, Puducherry 605102 and Campus Connection., a Soft skill, Industry Skills Training company, with its principal address at No.17, PV Iyer Street, Broadway Chennai - 600001.

WHEREAS, this MoU is agreed between SRI VENKATESHWARA COLLEGE OF ENGINEERING AND TECHNOLOGY and Campus Connection., for the Soft Skills Training and Campus Readiness Training Program for the **II, III & IV Year (All Dept) total 348 students** as agreed in the proposal / statement of work.

2. Statement of work

Campus Connection ., agrees to provide the services as described in the Proposal **Campus Readiness Training Program (Technical) for 6 days(36 hours)** based on the syllabus of proposal which includes class training & evaluation for , **B.Tech II, III & IV Year (All Dept) total 348 students, with a batch size of about 50 students.** On the average, training of six hours a day per batch (9.00 AM to 4.30 PM) with a lunch break of one hour (1 pm to 2pm) and two tea breaks(11.20 am to 11.35 am) & (3.20 pm to 3.35 pm).

3. Term of the MoU

The term of this MoU shall **commence on 08.02.2021** or the date on which both parties sign the contract, whichever date is later, and renewed every year thereafter or until the MoU is terminated pursuant to the terms contained herein, whichever event occurs first.

4. Responsibilities

Campus Connection ., agrees to:

1. Change / modify the training time / duration to accommodate any changes in academic with appropriate written (email) notice of 2 weeks in advance.
 - a. If an emergency change is made without prior notice, the right of suspension / re-plan for the cancelled session is at the discretion of Campus Connection ., and the

availability of resources.

2. Maintain student records on individuals it should contain the following: Student Attendance, course title, hours of instruction, location and dates; instructor(s) name(s), level of instructor certification, trainee details, progress & evaluation.
3. Provide the college a written notification of course dates, time schedule, location, and lead instructor for all courses. Such notification shall be provided at least seven (7) calendar days in advance of the course starting date. When courses must be scheduled to meet emergency training needs, representatives from college and Campus Connection ., may waive this seven (7) day notification. Requests for waiver may be made by email.
4. Verify instructor records to ensure that instructors meet or exceed standard qualifications.
5. The arrangements and expenses for travel from their place of work / residence for the Trainers shall be taken care by Campus Connection.

agrees to:

1. The college will provide classroom / seminar hall facility with LCD projectors for all the sessions for conducting - Soft skills/Industry interface / Guest lecturers.
2. Due to COVID 19, training will be conducted via Online thru Google Meet, SVCET will create URL Link so that link will be shared with Campus Connection Trainers and students to enhance the smoothness of the training program.
3. SRI VENKATESHWARA COLLEGE OF ENGINEERING AND TECHNOLOGY., shall be providing the Food and Accommodation for the trainers during the training program.
4. Any change in program/adjustment of classroom sessions will be intimated to both the parties (SRI VENKATESHWARA COLLEGE OF ENGINEERING AND TECHNOLOGY and Campus Connection) at appropriate notice in advance.
5. In consideration of the services (Training and Development) promises and performance of Campus Connection, the college agrees to pay as detailed in the Proposal, upon actual receipt of proper invoices, including time sheets, compensation upon the completion of each deliverable as specified in proposal.
6. If the Training program is stopped / cancelled in mid course for reasons other than quality / as agreed upon the proposal, the cancelling party should compensate the other party with the cost of training proposed for the semester.
7. Sri Venkateshwara College of Engineering and Technology ., will provide the infrastructures of class rooms, auditoriums, LCD projectors as and when required for the training purposes.

5. Termination

This MoU may be terminated only as follows;

1. By Mutual Consent of the parties.
2. If SRI VENKATESHWARA COLLEGE OF ENGINEERING AND TECHNOLOGY... fails at any time to continue funding for the payments and other obligations set forth herein, without prior notice, Campus Connection obligations under this MoU are terminated as of the date funding expires, and Campus Connection shall have no further obligations hereunder.
3. If Campus Connection fails at anytime to deliver training for more than three consecutive sessions, without prior approval from the college management, and if the feedback from the students is bad / not desirable, this MoU will be terminated as of the date.

6. Amendments or Modification

No amendment or modification of this MoU shall be effective against either party unless such amendment or modification is set forth in writing and signed by both parties.

7. Notice

Any notice required hereunder shall be made in writing, addressed to the party at the address set forth below.

8. General

Any dispute or difference arising in connection with this MoU, the same shall be settled by mutual discussions, failing which the decisions taken by the Management / Principal of SRI VENKATESHWARA COLLEGE OF ENGINEERING AND TECHNOLOGY... and M.VENKATESH- Chief Consultant, of Campus Connection., together will be final and binding.

This MoU signed hereunder shall be effective from the date of signing and will be valid for a period of one year, and shall be extended upon signing an extension thereafter.

9. Payment Terms

- 1) The course fee is fixed as Rs. 1500 /- (Rupees One Thousand five hundred only) per student.
- 2) 30% of the payment (after deduction of TDS) should be paid by the college once the training session is completed.

- 3) Balance 70 %(after deduction of TDS) has to be paid after the completion of campus recruitment on the prorata basis.
- 4) We will be providing Job Guarantee for 50 students in the final years.
- 5) The payment has to be made by the college in the form of Cash / Cheque to the favour of "CAMPUS CONNECTION" payable at Chennai.

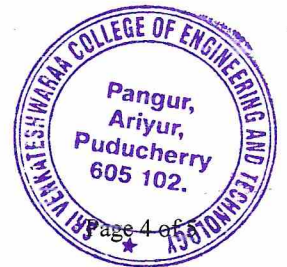
