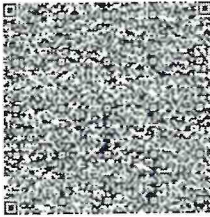



1. Students' industrial visits and in-plant training at the **MEDINGERS**.
