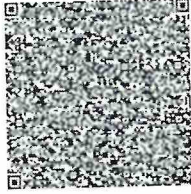

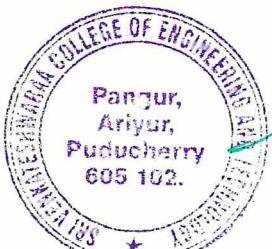

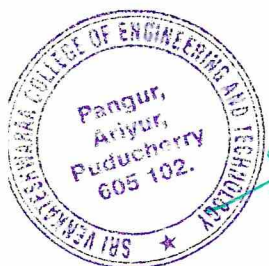

I. PONDICHERRY JUDO ASSOCIATION services to SVCET:

1. Awareness programs on Self Defense/Martial Arts will be provided.
2. Advanced Self Defense Workshop / Judo will be planned for the interested students in the college premises.
3. Preference given to our students team for the State and National Level Participation representing on behalf of the Pondicherry State.

II. SRI VENKATESHWARAA COLLEGE OF ENGINEERING & TECHNOLOGY services to PJA.

1. Infrastructure facility will be provided by the Institution for PJA to conduct their State level tournaments/ workshops/events
2. Interested students willing to learn Judo/Self Defense will be nominated and they will be trained to participate in State & National Events.

IV. Miscellaneous

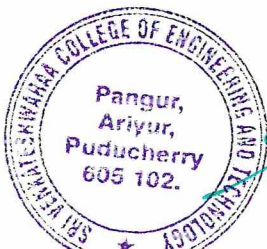
Modification of Agreement: Except for the above-mentioned professional activities, this Agreement should be modified only by the signed authorities of both parties.

V. Duration of this MoU

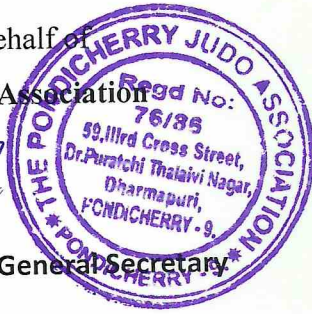
